Domestic Pricing Zone Map United States, Puerto Rico and Canada

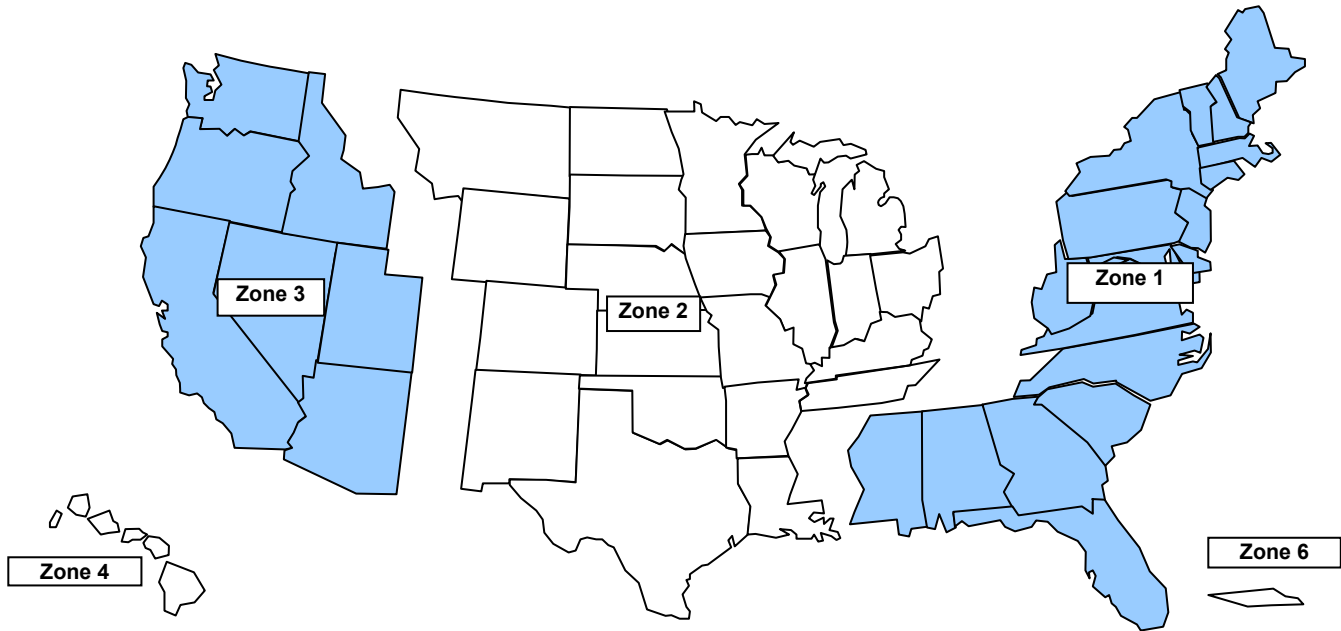
